## Report of the Trustees for the year ended 31 December 2024

The Trustees are pleased to present their report together with the financial statements of the charity for the year to 31 December 2024.

### Structure, Governance and Management

The Scottish Churches' China Group (SCCG) is an SCIO (Scottish Charitable Incorporated Organisation) governed by its Constitution. This SCIO was incorporated on 19 September 2012 as a result of a 'Change to SCIO' application by SC033740 Scottish Churches' China Group, which was an unincorporated association registered as a charity since 2 October 2002.

The SCCG is an ecumenical group incorporating representatives of Christian churches and fellowships in Scotland. We work closely with others including the Amity Foundation in China and the China Forum of Churches Together in Britain and Ireland (CTBI).

The denominational members of the Scottish Churches' China Group are:

- Chinese Fellowship
- Church of Scotland
- Roman Catholic Church
- Scottish Episcopal Church
- Society of Friends (Quakers)
- United Free Church of Scotland
- United Reform Church

Trustees direct the work of the SCCG and are known as the Management Committee. Members of the SCCG have voting rights and meet in Plenary sessions twice a year. Plenary meetings are open to anyone who is interested in our work or would like to learn more about China.

### Charitable Purposes

The purposes of the charity are the advancement of education, to promote good health and promote the benefit in the interest of social welfare of those living in China; to advance the education of the general public, membership of SCCG, churches and secular institutions about the cultural, social, political and religious aspects of China; and to promote, advance, encourage and support the Christian witness in China.

### Appointment of Trustees

New Trustees are nominated for appointment by the existing Trustees. There is no fixed term for Trusteeship. As part of their induction programme, new Trustees are required to understand their statutory responsibilities. Trustees met regularly throughout the year.

## Activities, Achievements and Performance

### Palliative Care Staff Training and Development

During 2024, we were very proud to have arranged, and participated in, an important step towards palliative care becoming a recognised medical discipline in China. On Tuesday 26 November, we joined in Shenyang with staff from the Palliative Care Ward, Shengjing Hospital, Beijing United Hospice and Palliative Cultural Center and, via a pre-recorded video, staff from Princess Alice Hospice in Surrey. In a small, but significant, ceremony, we all signed a Memorandum of Understanding to bring the European Certificate in Essential Palliative Care Skills (ECEPC) to China. (Jane Berg and Clair Sinclair of the Princess Alice Hospice had previously signed the Memorandum, a copy of which was brought to the Ceremony by Patricia Johnston.) This Memorandum of Understanding will allow, for the first time, the start of formal training for palliative care in China.

As part of the translation process, the revised Certificate material will incorporate Chinese traditions and medical options around death and dying, making it an appropriate Chinese Certificate in Essential Palliative Care Skills. The development of a Chinese Certificate is seen by our partners as a vital route to getting support for the ongoing development of palliative care. The signing ceremony took place in a traditional Chinese Medicine Hospital in Shenyang, part of which is the headquarters of one of the biggest trainers and providers of hospital carers, i.e. people who are paid to bring food and attend to personal care for someone while they are in hospital when the family are unable to do so.

We are all very grateful to Prof Max Watson, who wrote the European Certificate in Essential Palliative Care Skills, for his generosity in sharing this piece of work with countries that have no formal palliative care training.

## Rehabilitation Unit at Shengjing Hospital



We are pleased to continue to help develop training and resources for staff at the Rehabilitation Unit of Shengjing Hospital. Meeting in person with staff there in November 2024 highlighted a number of issues including a reduction in insurance payment support for patients requiring rehabilitative treatments. It is worth remembering that no hospital services are free in China even in 'public' hospitals.

Senior staff members also told us that a major difficulty is how to build a comprehensive rehabilitation service, often dealing with complex cases, without allied health professionals (physios, OT's, Speech and Language Therapists, etc). Many of the staff who provide physio

etc, do a four-year general therapist training and then decide, once they get a job, if they will be a physio, OT or Speech Therapist. Once in their role, any treatment they offer will be at the direction of a doctor who often isn't a specialist rehabilitation doctor. The doctor we have worked with for many years now heads up services for children and is desperate for the service to become more professional especially as a new National Children's Centre is being built right next to the Rehabilitation Unit.

The staff expressed an interest in resource- and expertise-sharing using the 'Project ECHO' platform. Prior to November's visit, we had arranged an online meeting in May with staff from the rehabilitation unit who are keen to incorporate the 'Project ECHO' model for staff training, sharing specialist knowledge and support. The Rehab staff have asked for training in how to work with children and adults who have issues with speech and swallowing, following a stroke or bleed on the brain. This is where working with Dr Sally Boa of Strathcarron Hospice in Scotland has been invaluable as she was able to highlight the differences between working with children and adults and the requirement to bring in two different sets of specialists to run this particular Project ECHO training.

One issue still being addressed is the use of simultaneous translation during the ECHO session. When we have tried it, it has not worked to a satisfactory level, despite an upgrade in the translation package. One way around this may be for Rehabilitation staff to be trained as Project ECHO facilitators and to run their own sessions. This was discussed during the November Partner Visit and is being considered by our Chinese colleagues.

## Nanjing Rainbow

During the Nov/Dec China trip, we had a return visit to Nanjing Rainbow (full title in China: 'Nanjing Rainbow Charity for Critically-Ill Children'). It occupies two floors of an orphanage located on the outskirts of Nanjing. The orphanage is currently home to five hundred orphans.

When we visited Nanjing Rainbow in 2023, there were plans to develop a 'foster parent' system where selected adults would come to the Centre and spend part of the day with a child but the child would always remain at the Centre as they needed access to the nurses and doctor on site. Over the year this plan has been changed in a really amazing way. There is now a second building, on site, where eight sets of parents (not the children's biological parents but selected foster parents) live, in apartments, with three or four children. The children come to the Centre each day but live in a home environment overnight. The Director told us how some of the children have just blossomed in this setting.

## Palliative and Dementia Care in Nanjing

This work currently is focused on requests from the Amity Rengu Nursing Home for the Elderly in Nanjing. Following a total refurbishment of the Home, which was completed in 2024, there is now a small Hospice Unit with three beds.

With the progress that has been made on the Chinese version of the European Certificate in Essential Palliative Care Skills [outlined above], we have now linked staff from the Rengu Nursing Home Hospice Unit and Nanjing Rainbow to our palliative care colleagues in Shenyang. The Rengu staff should be able to study for the Chinese Certificate in Essential Palliative Care Skills once it is up and running, and the Shenyang staff will talk to Nanjing Rainbow to see if the course would be suitable for them in their context. (Palliative and end of life care for children is very different from that for adults, so the Certificate may not offer the Nanjing Rainbow staff the skills they need.)

### **Caritas Social Services Centre (CSSC) in Shenyang**

There is a very difficult, and worsening, situation in Shenyang for the work of the CSSC, and for our good friend, Father Joseph Zhang, Centre Director. The Chinese authorities have curtailed what churches and Christian organisations can do and where they can work. There are also restrictions on financial support and it is currently very difficult for the CSSC to receive funds from overseas. The withdrawal of funding has led to some CSSC staff being made redundant, which is very sad. Ms Wu Wei, the candidate who will be studying for a MSc in Dementia Studies (facilitated and funded by the SCCG) is not affected by these redundancies as she is currently on maternity leave.

However, the CSSC still offers a room for people living with HIV/AIDS to come and meet together. Since the Cathedral complex is so busy, no one notices who is coming or going so it is an ideal setting for this vulnerable group of people. A group for elderly people still meets in the Centre but lunch is no longer provided, partly because they don't have the funds for it but also because there seems to be new regulations around who can/can't offer food.

The wider picture for the Church isn't encouraging. The Cathedral was closed for three years due to Covid and the number of worshippers hasn't returned to what they were pre-Covid. The pre-Covid English Mass regularly attracted 500 worshippers, many who were foreign students or business people based in Shenyang. The number of foreigners in the city has reduced drastically so the English Mass hasn't been reinstated. The small seminary hasn't had students for a number of years and far fewer women are coming forward to train to be religious sisters. Still, Father Joseph feels the Church has a central role to play in bringing a spiritual perspective to an ever-changing society that is leaving many people feeling isolated and unsure of their role or purpose. We are keeping in close contact with Father Joseph to see what support we can give.

### **Hospital Staff Care**

In 2023, at the request of Shengjing Hospital President, we met with the Head of the Psychology Dept, to look at developing a staff care programme. This project is currently on hold due to a change in leadership at the hospital, but we have continued to be in touch with the Psychology Department, meeting again in November 2024. We all hope there may be future opportunities to support this initiative.

### **Inclusion and Special Educational Needs**

In 2023, through the Amity Foundation, Nanjing Special Education University, requested a Scottish specialist in Special Educational Needs come to Nanjing for a three year placement or secondment at the university.

Considerable preparatory work was done throughout 2024 culminating in a productive meeting, in Nanjing, during the Partner Visit. This was led by the Vice Dean of the university and Ms She Hongyu, an Amity Associate General Secretary. At the meeting a number of key issues

were thrashed out leaving just a few formalities to be completed. If all goes well the placement would start in August 2025. This is the only college in China which focuses purely on training teachers to work with children with additional educational needs.

We continue to fund Ms Ma Xiaobo, who is nearing the end of her MSc degree in Inclusion and Special Educational Needs, an online course provided by Queen Margaret University. If she remains on track with her studies she will graduate in late summer 2025. Both before and during her studies we have supported Ms Ma by providing training sessions with Jasmine Miller, a former Principal Teacher at New Struan School, Alloa. Jasmine has extensive experience in the field of Inclusion and Special Educational Needs.

## Events and Publications

The 'Eric Liddell 100' was a programme of events and activities in 2024 to celebrate the life, faith, sporting and community service achievements of one of Scotland's iconic figures. A year after his success at the Olympic Games in 1924, Eric Liddell returned to China to continue missionary work there, where he lived until his death in a Japanese internment camp in 1945. The SCCG Convenor, Rev Alan Miller, represented us in June at a special Service of Celebration and Remembrance at St Giles' Cathedral, Edinburgh, to honour this remarkable life of faith.

We held our AGM and Spring Plenary in March and our Autumn Plenary in September. Our March Plenary session included a report with photos about our partner visit at the end of 2023. We also invited John MacMillan of the Eric Liddell Community to update us about events to celebrate Eric Liddell's Olympic Centenary. The Plenary meeting in September included two specially-recorded video presentations from partners in China, which were well received.

We continue to stay in touch with our members and supporters by regular email updates, including 'Mailchimp' eNewsletters. A 4-page printed Newsletter was published for both our Plenaries in March and September. We have an online presence via our website and Facebook Page.

## Final reflections from our Partner Visit Nov/Dec 2024

It was a very busy, productive - and inspiring - time in China meeting with partners at Shengjing Hospital, the Caritas Social Service Centre, The Amity Foundation and the Nanjing Rainbow Charity for Critically-ill Children. One of the lasting things from the trip is that it showed how important long-term partnerships are. We have partnered with Shengjing Hospital, the Caritas Centre and the Amity Foundation for over 30 years. That builds up a level of trust and mutual respect that enables open and honest conversations. The other aspect of a visit that is always encouraging, is how welcome we are made: the hospitality is second to none. There is a genuine sense of delight in us visiting people and seeing the work that they do. Small as we are as an organisation, our partnership is important to those we work with in China.

## Financial Review

The Trustees received grants, donations and gift aid and other income amounting to £33,178 (2023: £24,772) during the year, including modest bank interest. Expenditure of £27,580 (2023: £33,865) was incurred leaving a surplus for the year of £5,598 (2023: deficit £(9,093)).

Unrestricted income received during the year was £9,653 (2023: £5,322) and expenditure £6,904 (2023: £10,690). The unrestricted surplus for the year of £2,749 (2023: deficit £(5,368)) (plus a transfer from restricted funds of £2,000) increased unrestricted funds to £7,711 (2023: £2,962).

Restricted Funds received during the year amounted to £23,525 (2023: £19,450) and £20,676 (2023: £23,175) was spent, leaving a surplus for the year of £2,849 (2023: deficit £(3,725)) and restricted funds balance at the year-end of £17,680 (2023: £16,831) (after a transfer of £2,000 to unrestricted funds).

There has been a restatement of the prior year accrued liabilities from £1,302 to £1,260 which is not considered to be material.

## Reserves

The Trustees are pleased to report that a further partnership visit to China was made in November 2024. This eases forward planning and policy setting on Reserves.

This past year, the Trustees continued to employ a part time project worker to develop the work of the charity. We have the services of a self-employed publicity officer who continues to raise the profile of our work and that of our partners in China. In addition, we bought in the services of a professional fund raiser, for which we were able to get grant funding. Some of the employment costs are funded by grants restricted for that purpose and the remainder is paid from unrestricted funds. The Trustees continue to seek regular support for the unrestricted funds and the aim is to continue maintaining a minimum of £5,000 at any time, with unrestricted funds at 31 December 2024 of £7,711 (2023: £2,962).

## Plans for future periods

We will continue to support existing projects for which we have funding, continue good communication with partners in China listening to their advice on needs that we might assist with and we will continue to seek funding for the new programmes that we have identified and consider to be viable.

# Report of the Independent Examiner to the Trustees

I report on the accounts of Scottish Churches' China Group (SC033740) for the year ended 31 December 2024 which are set out on pages 11 to 15.

## Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). ## Basis of independent examiner's statement
